# **EXECUTIVE SUMMARY**

The former Coast Guard Administration Building sits empty and without power and is either slated for demolition or a complete renovation. The Canadian Police College (CPC) in partnership with the Royal Canadian Mounted Police (RCMP) and the Saint John Police Force (SJPF) would like to use the building for training until a final use is determined. The CPC/RCMP training will see participants from across the country train in Saint John on two separate occasions, once in December, 2018 and once in January, 2019.

The training will not be intrusive to the surrounding community and would only involve the interior of the building itself. The only activity visible to the public would be vehicles parked adjacent to the building.

This is an opportunity to support training initiatives for our National Police Force and further develop skills of local and national police officers.

#### **REPORT**

This report is generated as an information item relating to activities to take place at the former Coast Guard Site. The Administration Building sits empty and without power and is either slated for demolition or a complete renovation.

The CPC/RCMP are seeking to utilize the site as a training venue. The CPC/RCMP are planning to conduct training activities, December 4<sup>th</sup> through 6<sup>th</sup>, 2018 and January 22<sup>nd</sup> through 24<sup>th</sup>, 2019 inclusive.
