Purpose for Presentation (what is the ask of Council): To approve Street Closure of Grannan Lane and Canterbury between King and Princess on August 16th, 2019, for THIRD SHIFT contemporary art festival.

Background Information:

THIRD SHIFT is a festival of public contemporary artworks presented by Third Space, a not-for-profit artist-run centre in Saint John, New Brunswick. Established in 2015, THIRD SHIFT aims to offer citizens a unique opportunity to engage with contemporary art and re-imagine their city. THIRD SHIFT holds space for new experiences and communal exchange through the exhibition of temporary installations, interventions, performances and projections in the heart of Uptown Saint John. Motivated by the potential for deeper engagement, THIRD SHIFT is proud to announce it has expanded its schedule to include two days of artistic presentations and workshops leading up to our signature nighttime exhibition on Friday, August 16th, 2019. All activities are free of charge and open to the public.

THIRD SHIFT has occurred in this location for 4 years and is an established, free, all-ages, non-profit event. This year our application has been limited to only Canterbury Street while we are aware that other, similar events have been approved for this season for the same location. We take all required security precautions, public safety precautions, secure permissions from nearby businesses and residents. Additionally, given that the public expects the event to occur on Grannan Lane, we believe there will be a greater influx of pedestrian traffic on Grannan regardless of street closure, which could cause greater safety concerns if the street is not closed to vehicles.
