Community Standards Compliance Programs

Dangerous and Vacant Building Program

Inspection and management of the condition of vacant and dangerous buildings.

Management of the unsightly repair program for vacant buildings.

Minimum Property Standards Program

Inspection of and enforcement of safety and maintenance standards within occupied rental buildings.

Community Standards Program

Inspection, investigation and enforcement of unsightly premises.

Zoning by-law complaints.

Serious dog control cases.

Other property-related matters.

Ongoing 2024 Pilots

Community Enhancement Pilot - 15 Months

- 2 Positions Approved: June 26, 2023
- Dates Onboarded: December 11, 2023 & January 29, 2024
- Programs Enhanced: Dangerous and Vacant Building & Minimum Property Standards Programs

Expanded Community Standards Program - 24 Months

- 1 Position Approved: November 27, 2023
- Date Onboarded: February 20, 2024
- Program Enhanced: Community Standards Program (focus on Unsightly Premises & Zoning)





COMMUNITY ENHANCEMENT PILOT

Dangerous and Vacant Buildings

- New Technical Services Junior
 Engineer added December for 15 months.
- Seeking improved results, increased Unsightly Repair efforts.
- Focus on areas of priority.





DANGEROUS AND VACANT BUILDING PROGRAM

Results YTD

Item	2023 Results	2024 Results YTD	2024 Targets
Cases Resolved	47	29	60
Percent Repaired & Reoccupied	66%	76%	75%
Dangerous Buildings Notices	1	3	
Unsightly Repair Notices	3	4	10

Minimum Property Standards



New Minimum Property Standards Inspector added January 2024. (15 months)



New cases generated based on proactive approach.



Focus on priority areas:

- Lower West
- North End
- South Central Peninsula
