## 7.2 <u>Housing Accelerator Fund Grant Program</u>

Manager Housing, A. Reid, reviewed the submitted presentation "Housing Accelerator Fund Grant Program", noting that the program will help the City achieve increased housing supply over the next three years, in alignment with the goals of the Municipal Plan. The Program is comprised of three key grant streams including the Construction Challenges Grant, Missing Middle Housing Grant and the Revitalizing Rental Stock Grant. The HAF Grant program is a temporary program that will be in place between 2024-2026 until all funds are committed. Funding will be disbursed to projects that are most in alignment with the goals of the City and the HAF Action Plan.
