In the event that there is a conflict of terms among the General Terms and Conditions, the Product Specific Terms and this Order Form, the order of precedence shall be Order Form, the Product Specific Terms, and last the General Terms and Conditions.

The Product Specific Terms are hereby incorporated by reference and made part of this Agreement if they apply to your order. If the product referenced in the Product Specific Terms is not part of your order, the Product Specific Terms do not apply. If there is a conflict between Product Specific Terms and this Agreement, the Product Specific Terms control. Notices to Thomson Reuters Canada must be made in writing to Thomson Reuters Canada at Attn: Customer Relations, 19 Duncan Street, Toronto, Ontario M5H 3HI, or by email as set out at <u>http://store.thomsonreuters.ca/contact</u>. Notices to Subscriber may be given by Thomson Reuters Canada to the most recent address/contact-information in Thomson Reuters Canada's records for Subscriber. Notice shall be deemed delivered upon three business days after posting in the Canadian postal system, one business day after posting by email, or as set out in the Thomson Reuters General Terms and Conditions.

If you are (a) an existing subscriber, (b) currently billed Yearly, (c) adding content/users to your Agreement mid-contract resulting in a price change via this order, AND (d) you wish to keep your Renewal Date as is, two (2) separate billing events will occur. First, you will receive a credit against your most recent invoice for this contract. This credit will be calculated based on your existing Full Annual Contract Value. This will be prorated against the unused portion up to your existing Renewal Date. Second, in the following month, you will receive an invoice with a charge based off your new Full Annual Contract Value. This charge will be prorated to your existing Renewal Date. NOTE: The combination of these two amounts will represent your incremental increase. These billing events will be delivered at different times.
