Rents in our city have skyrocketed, pricing so many people out of the market.


Saint John has spent the last few winters scrambling to open temporary shelter spaces, knowing it's not a real solution. There are ways to better use resources and support people who need homes.

Dear Members of the Planning Advisory Committee,

Please consider this letter in full support of the Sunnyside Tiny Home Community.

Homelessness in Saint John has been at crisis levels for years. We need immediate, lasting solutions. The Sunnyside Tiny Home Community will provide 75 homes with wrap-around support by next winter, addressing a critical gap in our housing stock.

As an organization that builds and finances affordable housing in Saint John and throughout the province, we fully support United Way's effort to build deeply affordable homes. With about 400 people experiencing homelessness and many more at risk of losing their homes, the need is urgent. By my count, we currently have about 75 deeply affordable units slated to open next year—this project would double that number.

Delays to projects like Sunnyside put lives at risk and force the city to rely on costly, unsustainable temporary shelters. We need permanent housing solutions. The City can help by ensuring rezoning is achieved as quickly as possible to get this project underway.

To Whom It May Concern,

As a physician with 30 years of experience, including as Head of Emergency Medicine in Saint John for the past four years, I have seen firsthand how our healthcare system struggles to serve a community increasingly strained by homelessness. Emergency departments are designed to be a safety net, but how do we fulfill that role when we're also the admitting area, the holding area, the primary care provider, and, too often, the place where people come simply because they have nowhere else to go on a cold, Canadian evening?

Homelessness has profound consequences—not just for those who experience it, but for the entire community. It leads to preventable health issues, overwhelms emergency services, and diminishes the quality of care for everyone. In the past four years, the situation in Saint John has escalated to crisis levels. We need to build more homes immediately.

The proposed Sunnyside 75-unit community, with its integrated wraparound support services, is a critical part of the solution. It offers not just housing but the stability and resources people need to rebuild their lives. Every delay in this project compounds the suffering of those who are unhoused and intensifies the pressure on our healthcare system in Saint John. We must do everything possible to ensure these homes are built and ready for occupancy before next winter.

I fully endorse the proposed zoning change to make this project a reality. It is essential for the health of our community and the sustainability of our healthcare system.

Greetings through you Mr. Clerk to the Mayor and Councillors.

This letter is an initial public comment from the Fernhill Cemetery Company on the application for rezoning and Municipal Plan amendments proposed for Sunnyside Avenue.

Fernhill has not adopted a position at this time insofar as any possible objection or support on the proposal but reserves its right to do so throughout the process. We also have questions that are important to have answers to.

Some of those questions include, yet are not limited to:

- 1. What measures will be implemented to address any migration and set up of any tent community as has occurred around the city and as been the case around the Fredericton 12 Neighbours community?
- 2. What is the plan for snow management in such a tight footprint? Will there be a physical barrier along the Fernhill property?
- 3. What measures will be implemented to ensure that litter etc. does not make its way into Fernhill?
- 4. If security concerns manifest themselves in relation to the need to protect Fernhill property and the burial sites as a result of the development proposal will the Sunnyside Community managers take responsibility for addressing same?

5. We understand the current Municipal Plan definition of Park and Natural Areas highlights that "Lands in the City designated Park and Natural Areas are generally not appropriate for any form of development..."

The supporting Policy LU-113 goes on to say "Council intends that the Park and Natural Areas designation will permit a range of conservation and appropriate recreational land uses permitted in the City's major regional and community parks, environmentally sensitive or significant areas, lands that are located adjacent to watercourses, lands adjacent to the City's coastlines, estuarine areas, significant archaeological and geological sites, historic sites, designated heritage places and cemeteries.

Why would it be appropriate to vary the above provisions at this time and for this purpose given likely more promising locations?

Fernhill's contiguous neighbour the Shaarei Zedek cemetery shares the interest and concerns that have been expressed herein.

In closing we look forward to hearing much more information and answers to questions as we follow this matter and consider what if any position the Fernhill Cemetery Company may take.
