# LEVEL 1 HIGHEST HONOUR

# FREEDOM OF THE CITY

- 1. FREEDOM OF THE CITY BESTOWED UPON A MILITARY UNIT
- 2. FREEDOM OF THE CITY BESTOWED UPON A PERSON OR PERSONS.

### **CRITERIA**

- MILITARY UNITS MAY REQUEST THE FREEDOM OF THE CITY
- INDIVIDUALS AND MILITARY UNITS MAY BE NOMINATED BY A MEMBER OF COUNCIL OR THE PUBLIC

# FREQUENCY – AWARDED SPORADICALLY AS COMMENDABLE RECIPIENTS ARE IDENTIFIED AND APPROVED BY COUNCL RESOLUTION

HONOURARY AWARD – PRESENTED AT A CEREMONY OUTSIDE COUNCIL CHAMBERS OR AT A SPECIAL OR REGULAR MEETING OF COUNCIL. RECIPIENT INDIVIDUALS AND MILITARY UNITS ARE RECOGNIZED BY THE READING OF THE FREEDOM CERTIFICATE AND PRESENTATION OF THE CERTIFICATE.

MILITARY UNITS ARE ENTITLED TO PARTICIPATE IN A TRADITIONAL PARADE CEREMONY; TO "MARCH THROUGH THE STREETS WITH DRUMS BEATING. COLOURS FLYING AND BAYONETS FIXED".

# LEVEL 2

# CITIZEN OF THE YEAR

AWARDED TO A RESIDENT INDIVIDUAL, GROUP, BUSINESS OR ORGANIZATION IN THE CITY OF SAINT JOHN

#### **CRITERIA**

- A MEMBER OF COUNCIL OR 2 MEMBERS OF THE PUBLIC MAY **NOMINATE** ANY <u>RESIDENT</u> INDIVIDUAL WHO HAS MADE A SIGNIFICANT IMPACT ON THE CITY THROUGH THEIR EXEMPLARY ACTIONS, VOLUNTARY EFFORTS, ACHIEVEMENTS OR CONTRIBUTIONS, MAKING THE CITY A BETTER PLACE TO LIVE
- MUNICIPAL, PROVINCIAL AND FEDERAL OFFICIALS AND EMPLOYEES ARE NOT ELIGIBLE.

#### FREQUENCY – ONE TO THREE RECIPIENTS AWARDED ANNUALLY

AWARD – AN AWARD OF RECOGNITION MAY BE PRESENTED TO THE RECIPIENT AT A SPECIAL CEREMONY OUTSIDE OF COUNCIL CHAMBERS OR AT A SPECIAL OR REGULAR MEETING OF COMMON COUNCIL. PHOTOS TAKEN, CITY NEWS RELEASE ISSUED.

NOMINATIONS ARE RECOMMENDED BY THE COMMITTEE OF THE WHOLE, AND APPROVED BY COMMON COUNCIL

# LEVEL 3

# **COUNCIL COMMENDATION**

REPRESENTS THE EXPRESSION OF APPRECIATION TO AN INDIVIDUAL, GROUP, ORGANIZATION OF BUSINESS OF THE GREATER SAINT JOHN REGION FOR THEIR SERVICES AND/OR CONTRIBUTIONS

#### **CRITERIA**

 A MEMBERS OF COUNCIL MAY **NOMINATE** ANY INDIVIDUAL, GROUP, ORGANIZATION OR BUSINESS IN THE <u>GREATER SAINT JOHN REGION</u> WHOSE CONTRIBUTIONS HAVE BENEFITTED THE COMMUNITY AT THE MUNICIPAL OR REGIONAL LEVEL

### FREQUENCY – AT THE DISCRETION OF COUNCIL

AWARD – A CERTIFICATE OF RECOGNITION MAY BE PRESENTED TO THE RECIPIENT (S) AT A SPECIAL OR REGULAR MEETING OF COMMON COUNCIL PHOTOS TAKEN, CITY NEWS RELEASE ISSUED

NOMINATIONS ARE RECOMMENDED BY COMMITTEE OF THE WHOLE AND APPROVED BY COMMON COUNCIL

# LEVEL 4

# MAYOR'S CERTIFICATE IN RECOGNITION OF SIGNIFICANT MILESTONES

AWARDED TO INDIVIDUALS OR GROUPS WHO HAVE ACHIEVED SIGNIFICATE MILESTONES, SUCH AS 100<sup>TH</sup> BIRTHDAY, 60<sup>TH</sup> ANNIVERSARY, 10 YEARS IN BUSINESS, OFFICIAL OPENINGS

#### **CRITERIA**

THE PUBLIC MAY REQUEST A CERTIFICATE. IT IS AT THE MAYOR'S DISCRETION TO PROVIDE THE CERTIFICATE.

# **FREQUENCY**

MAY BE AWARDED CONTINUOUSLY THROUGHOUT THE YEAR
