The below listed conditions have been added to the 'Security Plan', following review, and have been notified back to the Applicant:

- 1.) Larger sized vehicles (ie: pick-up trucks, etc) will be stationed inside the barricades at the King Street and Germain Street 'gates', to prevent errant, intoxicated or otherwise intentional vehicle incursions into the crowd. Security staff at these positions will have the ability to move the vehicles in the event of an emergency.*
- 2.) As per the Applicant's 'Security Plan', the gates at the four street access points will be staffed by security at all times during the event; providing entry for emergency vehicles.*
- 3.) Security staff will assist with the enforcement of Section 136(2) of the Liquor Control Act (persons being intoxicated in a licensed area); security staff will bring such cases to the attention of the police officers assigned to the event.*
- 4.) Signage at each 'gate' will include barricades and 'Road Closed' notices.*
